### Software

Spreadsheet: Open Office Calculate (free) or MS Excel QuickBooks.com, GnuCash.com, Freshbooks.com, Outright.com Allows for inventory, invoices, simple to complex businesses, add-ons for payroll

### Legal Information

If you wish to start a business under anything other than your real name, you'll need to register a Doing Business As (DBA) so that you can do business as another name.

Registering your DBA is done either with your county clerk's office or with your state government. Google your state and "DBA" or "fictitious name registration" or search here: <u>http://www.sba.gov/category/navigation-structure/starting-managing-business/starting-business/starting-business/choose-register-your-busi</u>

### **Business Licenses**

You will need a vendor's license from your state if you sell a product or some services to collect and pay sales tax.

You may need other state's transient vendors or temporary business license if you travel into another state and sell.

Use SBA's search tool to find general business permits, licenses and registrations required by your state, county or city: <u>http://www.sba.gov/content/search-business-licenses-and-permits</u>

#### Tax ID number

Keep that Social Security Number secret! Use an Employer Identification Number (EIN) instead. An EIN is required if you hire employees or pay an independent contractor more than \$600. Get one EIN for all businesses you will ever own. Good for life! Application is free at IRS.gov search "EIN" or Form SS-4

Taxes: Federal Income tax:

0% up to a profit (net income) of \$6,100 (2013) 10% for profit of \$6,100 to \$8,925 (2013)

Teens file their own tax return but can still be theirs parents' dependent

Use Schedule C Business Income on Form 1040 to report business income and expenses

**Self-Employment Tax** (Social Security & Medicare for self-employed people) 15.3% of business profit over \$400 (the \$400 floor has not been adjusted in decades).

Example:Tom earns a profit from his micro business of 7,025. His Federal Income tax = 59 and his Self Employment Tax = 863. You can owe little in income tax, but owe a lot in SE tax!

#### **Reducing Taxes**

Household employees under age 18 pay no self-employment tax! You must work in or around a household doing childcare, lawn care, house cleaner, etc
