# WCCA Meeting Minutes October 17, 2018

President Al Shook called the meeting to order at 7:30 pm at the Ojibwa Bowhunters. The meeting was sponsored by the Stone Bank Sportsmen's Club, who provided the refreshments. The meeting was attended by 17 individuals, comprised of club delegates, the Wisconsin Conservation Congress and the DNR.

## **SECRETARY'S REPORT:**

The minutes of the September meeting were accepted as published.

#### TREASURER'S REPORT:

Awaiting the fundraiser check from Wern. The funds for the raffle were received.

A motion was made to accept the report subject to audit. The motion was passed.

## **Miscellaneous** – Some things to note:

- o The DNR launched a new application, Hunt Wild Wisconsin, available on most mobile devices.
- Bark River is closed due to reconstruction of the WIS 67 bridge, not sure who signed the permit without stakeholder involvement. It is now open again.
- DOT will be holding hearings in the next couple weeks regarding updates to Hwy 18.

## **COMMITTEE REPORTS:**

- DNR Ben Heussner
  - School Section Lake dam failed last spring, been drawn down all year. Proposing to close fishery to protect existing fish during ice fishing. Dec 1 – May 4. Public meeting November 13 at Ottawa Town Hall. Does not expect a lot of opposition.
  - Will be attending WCSFO meeting tomorrow and updating the council regarding how the fishery stands. He did request info from the bureau director:
  - Other Notes:

- Fisheree updates statewide: 40 positions have been filled statewide in the last two years and Ben is leading the staff development team (new employee orientation/training).
- Project on Granite River (driftless area) habitat work
- Was involved in Root River facility open house, egg take starting next week
- Just finishing up Strawberry Creek egg take for chinook in Sturgeon Bay
- Couple management plans upcoming: trout, sturgeon, Lake Superior
- Task force: property management/fisheree guidance
- Heavy equipment task force: eliminated quite a bit of equipment, now down 50% and need to get rid of 8 more by 2020. Harder to operate, but they are moving into rental and privatizing heavy equipment operation.
- Statewide aquaculture and fish farms management AB 160
- Lake Superior Fishing Agreement
- Walleye fishing has a great future here and 15,000 walleyes were recently clipped for identification.
- Ceded territory slot size recommendations
- Walleye stockings Pewaukee, Denoon, Beaver, Ottawa and others
- Draw down at Little Muskego failed to get rid of starry stonewort
- Eradication of carp on Rock River a natural virus brought down the population
- Perspective on R3 program (recruitment, retention, reactivation), including educational programs such as Hunter Safety – positive outlook.

## Conservation Congress –

- o Tom Daluga -
  - The upload game committee meeting was cancelled
- Larry Wehrheim
  - Still looking at continuous season or earlier opener for turkey, breaking the season apart.
- o MarySusan Diedrich -
  - Rules/resources committee not a whole lot, trying to get more representatives for Congress, especially younger individuals. Another regional training on CDAC. Looking at deer season, adopt a dumpster and/or kiosk (build and deliver).

#### Wisconsin Wildlife Federation –

- o George Meyer
  - Update on WWF workings and programs chronic wasting disease in regards to deer farms, where a double fence would be required. Opposition is expected, but hopefully by next year, the double fencing will be required.
  - Transportation of deer not fine-tuned enough.
  - Grouse hunting close grouse on November 30 (actually November 16 due to rifle deer). No good science, but impact study on the way for Michigan, Wisconsin and Minnesota.
  - Federal level wolf delisting. House bill has provision to delist, Senate bill does not, attempting to get to House version. The US Fish and Wildlife Service, by the end of the year, will delist. It should be easier to defend when the lawsuits incur.
  - Letter to Speaker Ryan and Sensenbrenner as Waukesha County had multiple projects receiving money from that program. The program expired at the end of September and will the Alliance write a letter to request permanent reauthorization.
    - Motion made and accepted for Alliance to write a letter to Ryan.
    - Motion made and accepted for Alliance to write same letter to Sensenbrenner.
  - Donation 4 cases of shot 7, steel shot. Guidelines: current affiliate, maximum 2 cases per application, must be used to support youth based hunt or safety field days. Must be planned and executed by affiliate organizations. Deadline is Feb 1.
  - Grant program for outdoor skills days, up to \$250, for youth based outdoor skills days (hunting, fishing or trapping).
  - 2019 Calendar available for purchase.
- Don Camplin
  - Two year course for high school seniors and college freshmen just finished. They write their own resolutions.

Put in resolution to remove gag rule on wardens.

## • Kids Fishing Clinic -

- o Ron Gray
  - We lost one park in Milwaukee County, but regained the one in Waukesha County. No ice fishing clinics in Waukesha: 5 in Milwaukee County. Spring will have 3 in Waukesha, Milwaukee 11, Racine 1, Washington 1, Sheboygan 1. Could always use a new club and volunteers are welcome.

- Al also spoke with Musky guides/PKE Lake for wounded warrior/veteran trips. Opportunity is there, we have to show what we're doing in regards to donations in order to get 501 c3. Clubs needing help should ask for funding..
- o Range from 1550 to 300, just for one club, along with sponsoring trap clubs, such as buying a pallet of shells and donate one each year. Condolences to Jane Schmittinger on the loss of her father, aged 93, a WWII veteran.


