### **WCCA Meeting Minutes April 20, 2022**

### **WCCA Board Meeting 715pm May 18, 2022**

#### **SECRETARY'S REPORT**

Membership was asked if there were any corrections or additions to the March 16, 2022 General Meeting Minutes. Motion by Wincek, second by Frasier to accept the Minutes as published. Motion carried. Annual report filed with the State.

1. Jeffrey Bode, Lac LaBelle Lake Association requesting \$10,000 for \$30,000 project building a carp barrier for Lac LaBelle. (Carp coming upstream from Mississippi) Electric Barrier removed creating a safety hazard. Waiting on DNR approval. Would like this done by May 2022. Ben Hauser, DNR Fish Biologist, working with Association and approves project. Will send e-mail follow-up. Temporary nets will not work as damage caused by floating logs.
2. Frank Schuh of Schultz Rod & Gun requesting \$400 to offset costs associated with "Take Aim at Cancer" Shoot on 9-10-22. No charge to participants. Would like money by September 1.
