#### Report of the Convening Consistory Of Classis Central US – March, 2022

#### Brothers,

We are sincerely grateful for the privilege to act as your Convening Consistory of the March, 2022 Classis Central US. We hope that our efforts will be found acceptable, and that they will provide everything you need while conducting the work of the Classis. The following constitutes our initial Provisional Agenda report.

#### September 22, 2021

The Consistory reviewed a series of communications regarding a request by Christ Reformed of Sioux Falls to modify the language of Article 17B in the Fall 2021 Classis Central US minutes; specifically, to remove the original more explicit language used and state only that grounds were presented. After extensive discussion, a motion was made, seconded and carried to approve removing the explicit language and only reference that grounds were given. The arguments and grounds given by Christ Reformed were found to be substantive.

#### October 6, 2021

Assignments were made in regard to carrying out the various tasks necessary to prepare for the Spring Classical meeting.

January 5, 2022 Reports were received from those charged with making the necessary arrangements for the Spring Classis. It was determined that everything was moving along smoothly except that most hotels, due to Covid, are no longer offering blocks of rooms. Work will continue on recommendations for lodging.

January 10, 2022 A block of rooms was arranged at a nearby hotel and a backup hotel has also approved.

## REPORT OF THE STATED CLERK January 10, AD 2022

#### Dear Brothers,

Since my last written report on September 11, 2021, I have attended to the following matters:

#### Classis Central U.S. - Official Church Visitors Report

Church:Providence United Reformed Church- Des Moines, IowaDate:Monday, 19 July 2021Classically appointed church visitors:Rev. Spencer Aalsburg and Rev. Joel Vander Kooi

This official visit was announced to the Des Moines Congregation two weeks prior to the visit. All 4 members of the Des Moines Council were present: 1 Elder, 1 Pastor, and 2 Deacons. All the office bearers are required to sign the form of subscription when they are installed to office. The visit was conducted by Rev. Spencer Aalsburg who read 'C.O. Art. 27 – Church Visitors' aloud. Acts 2:36-47 was read and used as a discussion guide in conducting the official visit with a special emphasis on the spiritual life and the weekly worship of the Des Moines congregation.

Council members testified to the faithfulness of God in preserving the Des Moines congregation in spite of several families moving away. Worship services are held twice on the Lord's Day and on special religious holidays. These Worship services are Word centered, Christ centered, and God glorifying! Priority is given to the Psalter in the singing of the congregation. Concern was expressed that many church members live a great distance from church and have the habit of attending only one worship service per Sunday. This calls into question their level of commitment to the life of the church and their eligibility to serve as officers within the church.

Council members put special emphasis on the Grace of God as they experienced it in their corporate worship services, especially through the faithful preaching of God's Word and a worship service well planned around God's Word. Appreciation was expressed for the work of Pastor Jody Lucero who has faithfully served as their under-shepherd for nearly fifteen years.

The Elders meet monthly and faithfully rule in the Name of Christ. They maintain good discipline in the Des Moines Congregation and exercise a loving care over the flock. The Sacraments are faithfully administered according the Word of God and our Church Order. Parents presenting children for baptism are instructed in the meaning of baptism. Visitors on Communion Sundays are asked to fill out a 'Communion Request Form'. The Des Moines Congregation urgently needs more men who are qualified for the office of Elder.

The Deacons meet monthly and report to the elders on their work, the Deacons records for the last two years 2019 / 2020 were found to be in good order. The Council takes responsibility for the honorable support of their pastor and does its best to follow Synod's guidelines regarding Retirement, Disability Ins., Life Ins., and Health Ins.

The Des Moines Council and Congregation seek to practice evangelism as a way of life rather than a series of programs. The Church visitors commit the Des Moines Congregation to the Grace of God and His Blessing upon their faithful worship and ministry in Spirit and in Truth.

This official visit was announced to the Sioux Center Congregation two weeks prior to the visit. Nearly all 13 members of the Sioux Center Council were present, including their pastor, Rev. Jon Bushnell. Opening Devotions were led by Rev. Spencer Aalsburg, who read Acts 2:36-47 and used this passage as an outline to guide the questions and discussion of the evening.

Council members were in good spirits and testified to the faithfulness of God in blessing them with the faithful preaching of the Word and the administration of the Holy Sacraments. Worship services are held twice on the Lord's Day and on special religious holidays. Various Council members testified to the evidence of God's Grace and the work of God the Holy Spirit in their church fellowship, the sharing of one another's burdens, and the willingness of church members to minister to one another's needs without being asked or assigned to do so. The deacons also report a joyful spirit of giving and contributing to the needs of God's saints, as well as the budget of the church.

The Sioux Center Congregation has been blessed with over 100 children and young people and continues to grow. Additionally, every school year sees their numbers swell with students from Dordt University, who are encouraged to sign up for a 'Student Membership' at Sioux Center URC so that they will have a church home while away from home. These students have been a tremendous blessing to the congregation and vice versa. Space and facilities are becoming a challenge, and the Council and Congregation are on the lookout for solutions to this challenge.

The Elders meet monthly and are faithful in their oversight of the church, the Minister of the Word, and the members at Sioux Center URC. Family Visitation is conducted annually over a period of 3-4 months. The Deacons also meet monthly and report to the elders on their work. Both the Deacon's minutes and the Council's Minutes for the last two years (2019 -2020 up to the present date in 2021) were found to be in very good order. #### Classis Central US United Reformed Churches in North America Church Visitors' Report Immanuel URC DeMotte Indiana

On the evening of April 20, 2021, at the invitation of the Council of Immanuel URC (DeMotte IN) Rev. Ed Marcusse of Oak Glen URC (Lansing IL) and I conducted a regular church visit per the provisions of Article 27 of the Church Order. The brothers warmly welcomed us.

The visit was opened with prayer and with Elder Rudy Tolkamp reading and offering comments on Ezekiel 34 and John 10:7-18. Rev. The elders are faithful and diligent in overseeing the doctrine and life of the congregation in a spirit of love and encouragement. When necessary church discipline is purposeful and practiced in love. The elders also oversee the work of the deacons through regular monthly reports and meetings. They oversee the church education activities through approval of material to be used and the teachers/leaders as well as serving as Catechism teachers and conducting regular, periodic visits to the classes. The elders, with a fellow elder, strive to annually conduct family visitation with each family in their district.

The elders are diligent in ensuring that the Word and the Catechism are faithfully, and regularly preached and Christian education is encouraged and supported. The elders regularly meet with Rev. Rossi to discuss his work. He provides a monthly written report to the elders for their review. The elders meet with his spouse every six months to discuss work/life balance. Rev. Rossi is provided one Sunday evening service out of the pulpit each month. Additionally, an elder and a deacon meet with Rev. Rossi annually during the budget preparation process to discuss his financial needs.

The deacons are faithful and diligent in administering the resources provided by the congregation for the support of various mission and other Christian causes including addressing individual financial needs through benevolence. With respect to the counting and handling of the monies donated, the deacons were encouraged to consider policies

and procedures which ensure that more than one deacon count the proceeds of the collections and that more than one deacon is responsible to deposit the collections in a locked bag with the bank on Sunday evening. The deacons ensure that annual contributions are timely made to the federation and to classis. The approved giving causes and the missionaries supported are annually reviewed.

The Council was encouraged to continue to make use of secure offsite storage for all of the records of the congregation including minutes of meetings, correspondence, membership information and the like to ensure the ability to recreate the records in the event of a situation in which the current storage arrangements are damaged or destroyed.

Rev. Alons opened the visit with prayer. Rev. Marcusse led the visit using a series of questions designed to stimulate discussion with the brothers regarding whether they were faithfully performing their duties, adhering to sound doctrine, observing in all things the adopted order, and properly promoting the edification of the congregation by word and deed.

We were pleased and encouraged by the responses of the Lynwood Council. Two worship services are held on the Lord's Day during which the Word and the Catechism are being faithfully preached. The Lord's Supper is administered seven times per year and mutual censure is conducted per the requirements of Church Order. The business of the church is regularly attended to through monthly meetings of the elders, deacons and Council. The elders oversee Sunday School and Catechism instruction, Bible studies and the other church sponsored activities (GEMS, Cadets, Young Peoples) by approving the materials used and the teachers/leaders. Rev. Alons teaches the high school Catechism classes and a pre-profession of faith class. The elders teach the other Catechism classes. The elders periodically visit the Sunday School and Catechism classes as well as the Bible studies and other activities taking place (GEMS, Cadets and Young Peoples' meetings). Seeking to obey our Lord's call in Matthew 28, there are focused activities and efforts to reach out to the surrounding community through "Love for Lynwood" during which members of the congregation participate in community support activities such as working in the local parks picking up trash, attending to flowers and shrubs and the like.

There appears to be an atmosphere of love, mutual respect and encouragement among the elders and deacons. The elders are faithful and diligent in overseeing the doctrine and life of the congregation in a spirit of love and encouragement. When necessary, church discipline is purposeful and practiced in love. The elders oversee the work of the deacons through regular monthly reports and meetings. The elders are preparing to begin a cycle of family visitation with the goal of meeting with each family in their district once every two years. Although personal visitation was limited by the recent COVID-19 restrictions, the elders were faithful in continuing support and encouragement of the congregation via non-personal contact means including phone calls and the like.

The elders are diligent in ensuring that the Word and the Catechism are faithfully and regularly preached and Christian education is encouraged and supported. The elders regularly meet with Rev. Alons to discuss his work. The elders strive to support and encourage Rev. Alons in his work.

The deacons are faithful and diligent in administering the resources provided by the congregation for the support of various missionaries and other Christian causes including addressing individual financial needs through benevolence. The approved giving causes and the missionaries supported are annually reviewed. The deacons faithfully budget for the annual contributions to the federation and to classis. Since the deacons make use of an individual who is not a deacon to process the payments approved by the deacons, they were encouraged to ensure that the contributions are being timely and faithfully made as directed by the deacons. With respect to the counting and handling of the monies donated, the deacons were encouraged to consider policies and procedures which ensure that more than one deacon is physically involved in the deposit of the collections in a locked bag with the bank.

All the records of the congregation, including minutes of meetings, correspondence, membership information and the like are kept in physical form on the church site and are also all stored electronically using cloud storage to ensure the ability to recreate the records in the event of a situation in which the current physically storage arrangements are damaged or destroyed.

Overall, the visit with the Council of Lynwood URC went very well. We commended the office-bearers for their diligence and faithfulness, and we encouraged them to stay the course. It was a blessing to hear the reports of the brothers regarding the faithfulness of the minister, elders and deacons in the execution of the tasks and responsibilities to which the Lord has called them. We rejoice with them as we received the report that the spiritual condition of the congregation is good and that there is growth in Christian love and faithfulness and an excitement and enthusiasm to serve the Lord among the brothers and sisters in Christ worshipping at Lynwood URC. #### The Church Planting Advisory Committee Report to Classis Central U.S. March 7-8, 2022

Esteemed fathers and brothers in our Lord Jesus,

The men currently serving on the Church Planting Advisory Committee (CPAC) consider it a privilege to aid classis in its mission efforts, and we thank you for the opportunity and for your support. CPAC continues in its regular functions (see *Rule of Procedure*, IV. B. 4), meeting monthly by teleconference. On Nov. 17-19 we had a face-to-face meeting in Schererville, IN – our first with Rev. Roberto Rossi, the most recent addition to this committee. We are very pleased now to have serving on CPAC a member of our overseeing consistory at Immanuel URC in DeMotte. At this meeting we gave some attention to the developing Latino Mission at Cornerstone URC of Sanborn; we give the Lord thanks that with the aid of Arturo Gomez they have begun outreach to the Hispanic people around them.

At our fall meeting the committee also considered how things might continue to develop with the handful of people in Columbus, NE, who hope one day to begin a URC plant in their town. CPAC remains in regular contact with this group, largely through Zoom video conferences. During the summer months we (Revs. Lucero & Wories) led them through a study of biblical, Reformed worship with the help of the book *With Reverence and Awe* by D.G. Hart & John Muether – this study concluded on Sept. 30 with a review of a public worship service held at Redeemer URC, Orange City. We have advised the group in Columbus to make use of the helpful 9Marks book *Evangelism: How the Whole Church Speaks of Jesus* by J. Mack Stiles. These dear saints are admirably committed to thoroughgoing study for their own growth as disciples of Christ, but it will be important for them to be equally committed to sharing the riches of God's truth and grace with others for the making of more disciples. If the Lord God is pleased to bless this group with some numerical growth, CPAC will want to connect them with one of the consistories of classis. If a consistory is interested in initiating that discussion, please contact us.

We concluded our face-to-face meeting last fall by visiting with Rev. Ruben Sernas, who reported that his ministry among the Latino people of Chicago Heights has been especially challenging during the virus pandemic – he feels the need for an administrative assistant or a co-laborer in ministry so that he can remain focused on teaching. Our discussion resulted in asking Rev. Sernas to complete El Pacto's Annual Update *not* this winter but rather next summer when their fiscal year has been completed (we will look to include that update in the agenda for the classis meeting to take place in the fall of 2022).

CPAC remains in contact with the Pella consistory, which strives to provide Rev. Pablo Landázuri with faithful care. Their Annual Update for the Quito mission work should follow this report (we remind you that Covenant-Pella does not oversee a church-plant in Quito but only the missionary). We praise God for many blessings upon this developing ministry – three men are now being trained for the Gospel ministry; a new church plant has begun in the southern part of the city. Consistories are encouraged to give due consideration to this Annual Update so that it can receive the attention that it deserves at our spring classis meeting. Below you will find our one recommendation regarding this mission work.

#### Annual Update for Assisted Mission Works of Classis Central U.S.

Consistory Updating: Covenant Reformed, Pella Church Planter: Rev. Pablo Landázuri in Quito, Ecuador Date: December 14, 2021

## 1. What is going on in the life of this church (studies, events, activities, worship services)? What has changed over the last year?

#### Studies:

Rev. Landázuri teaches a midweek study which is held in Luz de Vida building and broadcasted through zoom. He also teaches a basic and membership course every Sunday after the morning service for those visitors interested in becoming members of the Church. At this time a family and four individuals are taking the course. Three more families have expressed their desire to take the courses eventually.

#### Worship Services:

Luz de Vida offers two worship services every Sunday at 10:00 am and 5:00 pm. Our Misión Reformada del Sur (Reformed Mission of the South) offers two services as well at 10:00 am and 3:00 pm.

#### Licensure Examinations:

Mr. Steve Wuori was licensed during 2020 but had to return to the U.S. in May 2021 due to job related issues. Mr. Ronald Cagua a student of the Programa de Formación Pastoral sustained his examination for licensure on October 2021. Mr. Johan Pintado is expected to be examined by the end of December 2021, and Mr. Jean Carlos Morán in January 2022. All three of them are full time students of the Programa de Formación Pastoral.

#### Programa de Formación Pastoral and Seminario Reformado de las Américas:

As reported last year, the Programa de Formación Pastoral\_was started in order to train local men for ministry. At this time three men (members of Luz de Vida) have completed their first year, and several others from different churches and countries have taken some courses for credit or as audit students.

During the first year the following courses were offered: Greek 1 and 2, Hebrew 1 and 2, Hermeneutics, Theological Foundations, Liturgics, Homiletics, Covenant Theology, Apologetics 1, and Doctrine of God.

Starting January 2022, the Seminario Reformado de las Américas (SRA) will be taking up the training offered by the Programa de Formación Pastoral. SRA is a branch of City Seminary in Sacramento, CA, an institution overseen by men of the Reformed Church in the United States (RCUS). Its goal is to provide sound training to the Spanish-speaking world from a distinctive Reformed perspective and faculty. Three men will be teaching in this Seminary: Rev. Ruben Zartman, Rev. Valentín Alpuche and Rev. Landázuri.

## 2. How are your prayers being answered? What joys and growth (spiritual & numerical) are you experiencing? What struggles? What are your current prayer requests?

Despite the great difficulties Ecuador faced during the pandemic, the Lord allowed Luz de Vida to start a church plant and train men through the Programa de Formación Pastoral, now transitioning under the administration of the Seminario Reformado de las Américas.

As mentioned, three men are currently working full time on their ministerial training with the goal of becoming pastors and church planters in Ecuador. This is definitely an answer to prayer.

There has been a small reduction in membership because two families and one individual transferred their membership to churches outside Ecuador. Also, one member passed recently. However, thirteen people are expected to be received as members. Some already finished the required courses and were interviewed, and some others are about to finish the courses.

## 3. How many people are involved with this work? How has composition of the core group changed?

At this time Luz de Vida has 102 members. The core group is technically the same. The congregation grows organically, fundamentally through the witness of the membership to other friends and family.

A group of about twenty members of Luz de Vida are currently attending the Church plant in the South of the city.

Luz de Vida has a Council composed of: Rev. Landázuri, Rev. Donoso (E); Elders: Mr. Fausto Mora, Mr. Franklin Bayas, Mr. Ernesto Ordoñez (candidate to office of elder); Deacons: Mr. Francisco Campos, Mr. Esteban Grijalva and Mr. Ronald Medina.

#### 4. What efforts are being made to promote participation in this group?

The Misión Reformada del Sur was just started. Only four services have been held so far. Services are offered under the supervision of a Luz de Vida Council's official. At this point our goal is more evangelistic.

#### 5. How is the vision of this church plant being advanced or changing?

Our vision has remained the same with no fundamental change. The objective is to plant confessional Reformed churches in Ecuador.

#### 6. What progress is being made in calling a minister?

Rev. Landázuri is pastoring Luz de Vida. We expect to have three men trained for the ministry in three more years.

#### 7. What progress is being made in training office bearers?

The Pastoral Training Program is an answer to that need. For more details, see point 1 above.

Before the pandemic every fifth Monday was used for elder and deacon training. We are hoping to resume this practice in 2022. A workshop for elders and those interested is scheduled for January 2022.

#### 8. What challenges have you experienced in faithfully shepherding this church plant?

The main challenge during this year has been the pandemic. The Ecuadorian government has been very strict on imposing restrictions on some groups, including churches. Thankfully we have been able to resume almost all of our regular activities.

A case of discipline is being managed by the Consistory at this time.

## 9. What kind of community outreach is occurring? How comfortable has the congregation been in embracing new visitors?

Luz de Vida feels very comfortable performing its mandate to reach out and to embrace new visitors. Despite our efforts to reach neighbors through door to door visits, very few attend Luz de Vida. Family and friendship ties seem to be the way the Lord has used more effectively. A couple of families have recently started attending more faithfully after asking for counseling on marriage issues.

A significant way of reaching out is the church plant in the south of the city and the training of three Luz de Vida men. Each of these men study full time and receive a stipend of 500 USD per month. All these efforts are funded only with Luz de Vida local offerings.

# 10. How have the proposed plans changed? What change have you seen in the group's assets and liabilities, strengths and weaknesses? How have you handled successes? How have you handled failures?

Essentially our vision and plan remains the same. Luz de Vida has a clear Reformed identity; it understands the foundational importance the Word has in its life and missional calling; the church seeks to be faithful in its testimony to the community. The Lord has blessed us with two more deacons, another elder, and a new candidate to the office of elder during this year.

Successes and failures are generally taken with humility and maturity. Luz de Vida's Consistory has older men with much experience in church life and with an apt piety that have been key in supporting Rev. Landázuri's ministry.

Dear Brothers of Classis Central US,

Thank you for the privilege of serving the churches in the important work of ecumenicity. We are grateful to the Lord that we were able to meet together at NAPARC with the other member churches this past November. You have had opportunity to read our report on NAPARC, as well as the press release from NAPARC. It was another time of joyful and refreshing fellowship and encouragement!

CERCU has continued its practice of meeting via Zoom at least twice a year, and then meeting face-toface at NAPARC. Six of our committee members were able to attend NAPARC this year.

Our dear brother, Rev. Rick Miller, passed away the week after NAPARC. We will miss his passion for ecumenicity, and his candid way of speaking during our discussions. He brought great joy to our committee and he will be greatly missed.

The main fruit of our work recently has been the survey that was sent out to the churches. At the time of the writing of this report, we have not yet processed the responses from the consistories or councils. Our plan is to meet together in early March to assess the survey responses.

By way of reminder, here is the first part of the synodical mandate for CERCU:

"With a view toward complete church unity, the Committee for Ecumenical Relations and Church Unity shall pursue and make recommendations regarding the establishment of ecumenical relations with those Reformed and Presbyterian federations selected by synod and in keeping with Article 36 of the Church Order."

The design behind the survey that was sent to the churches was to get feedback from the churches regarding our ecumenical activity and discussions. Repeatedly in this Classis there have been opportunities to ask questions, to talk with the CERCU representative, or to raise any concerns or objections the work of ecumenicity. It has become apparent that the importance of the work of ecumenicity is not appreciated. CERCU wonders why this is the case. Other classical representatives receive the same underwhelming response. One thing we hear from other NAPARC churches is that the URCNA functions like independent congregations. They wonder how the unity of the Spirit in the bond of peace function even among our own churches. Perhaps this independent spirit is the root of the indifference toward ecumenicity that is being observed. Ecumenical relationships between churches are a witness to the world of the power of the gospel to unite and reconcile believers together, even believers from different Reformed and Presbyterian churches and practices.

CERCU wants to carry out its mandate faithfully. We are asking the churches to help us do that.

#### Classis Central U.S. Website Oversight Committee Report

#### Brothers,

The purpose of the Website Oversight Committee (WOC) is to maintain the federation's website located at <u>https://www.urcna.org</u>. The current Webmaster, Mr. Gary Fisher, does the majority of the work and keeps the Classical delegates informed of any major issues or developments throughout the year. The following is a summary from the reports the Webmaster has provided to the committee over the past year.

In the first half of 2021 the website underwent a successful "mechanical" upgrade and various fixes have been taking place throughout the rest of 2021.

One matter I'd like to ask you again to bring to your Classis member churches is the system we have in place for self-recovery of login credentials. I still get requests every week from churches that have misplaced their passwords. This is no burden on me, of course, but the churches could save themselves considerable time by using the "Forgot Username? / Forgot Password?" feature to get online in minutes instead of waiting for email back and forth.

Despite the continued efforts of Mrs. Luth, our Statistician, in prompting churches to keep their statistics and other information up to date, this remains a struggle, with many churches neglecting to make any updates except the most major ones, e.g. a ministerial change, until they've been pled with, cajoled, and sometimes threatened at the close of the year. For example, we often aren't informed of a church's current clerk until his term is almost over, a huge inconvenience (at best) to other churches, committees, etc. needing to contact them. If you look at the Federation Statistics posted twice a month under the Classes tab in the top menu (while logged in) you'll find that many churches are currently reporting NO Baptisms, NO Professions, and NO growth to date in 2021, which would be troubling if it weren't so absurd. PLEASE try to encourage the churches of your classes to make a habit of updating their info whenever it changes, and of confirming their online info at least every three or four months. Sorry to sound like a broken record, but keeping up-to-date info was one of the main reasons the website was created.

The website received around 410,000 visitors in 2021.

Lastly, the Trinity Psalter Hymnal app is now available for both IOS and Android. Details are on the site but in brief the app includes every song from the TPH in both text and musical format as well as a simple, but acceptable, synthetic piano accompaniment for each song. There are several more features, and the developers expect to be adding more (possibly including the Forms and Prayers and/or the Three Forms) and improving the app at no additional cost. The cost is \$9.99.

#### Overture to Classis Central U.S. March 2022

#### Introduction

Redeemer United Reformed Church in Orange City, IA, wishes to overture Classis Central U.S. to overture Synod Redeemer 2022 (or the next Synod of the URCNA) to amend the *Church Order* and the *Regulations for Synodical Procedure* to establish national synods in addition to a general (international) synod where delegates to the general synod are chosen by the classes.

#### Background

The idea of national or regional synods is not new. Regional synods were prescribed in the Church Order created by the National Synod of Dordrecht (1618-1619) and have a long history in the Reformed tradition. They have helped expedite the work of general synods. When the broadest assembly is a delegated assembly where not all the consistories are directly represented, regional synods allow for greater participation of all the consistories in those matters that proceed to the general synod.

As our federation grows, a general synod with every consistory represented will become more of a convention than a deliberative assembly. Already we have the prospect of a synod with over two-hundred delegates meeting for only five days, which does not allow for the majority of delegates to enter into debate. Increasingly, the heart of synod's deliberative work will be done in smaller advisory committees with the plenary sessions limited to voting up or down the recommendations of the committees. That is the direction in which we are moving.

Recent developments regarding cross border restrictions provide added incentive to have a general synod where it is not necessary for every consistory to be represented.

Our Reformed church order tradition from Dordrecht has long employed the practice of classes choosing the delegates for the general synod. The URCNA rejected that idea at its inception for a few reasons. The primary reason was that those who came out of the CRC thought the conservatives had lost control of the CRC because they had been underrepresented at the synods, that is, if every church had been represented, the conservative cause could have won the day. But that reasoning ignores the fact that since the early 1950's, most CRC ministers had imbibed deeply of liberalism at Calvin Seminary and, when at classis and synod, encouraged by their peers, often voted more liberal than they dared to preach at home. It is also the case that when women elders and ministers were approved based on a hermeneutic that contradicted the confessions, only about 10% of the CRC membership left. Progressive leanings and institutional loyalty, among both clergy and laity, were far more pervasive in the CRC than confessional integrity. The demise of orthodoxy in the CRC in the 1990's was inevitable regardless of whether all the churches had been represented at synod. Those who wanted to uphold the confessions were far fewer in number than they knew at the time.

We also rejected the idea of limiting the number of delegates to synod because we were small in number, came from all over the US and Canada, and needed time to get to know each other. We were dealing with foundational issues (e.g. a new church order) where input from everyone was vital. Now, our foundations have been laid and we are no longer small. We have established lines of communication by which we are able to keep in contact with one another so that a general synod meeting is no longer essential for that purpose.

This overture envisions a system where the general synod would normally meet once every three years and two national synods (one in the US and one in Canada) would also meet once in three years, perhaps

about four to six months before the general synod (or whenever they see fit), although the national synods could meet more than twice between the general synods if they so desired.

#### Overture

Redeemer URC in Orange City, IA, overtures Classis Central U.S. to overture the next synod of the URCNA to amend the following articles of the *Church Order* and its *Appendices*, and the *Regulations for Synodical Procedure* as indicated. [Strike through indicates removal from the present wording. *Italics* indicates addition to the present wording.]

#### 1. Article 16 – The Four Assemblies

Among churches belonging to the federation, three *four* assemblies shall be recognized: the consistory, the classis, *the national synod*, and the *general* synod. Classis, *the national synod*, *and the general* synod are broader assemblies that exist only when meeting by delegation. Only the consistory is a continuing body.

#### 2. Article 25 – Delegates and Matters of Broader Assemblies

Those delegated to the broader assemblies shall be seated only with properly signed credentials, and each delegate shall have only one vote. In the broader assemblies only those matters that could not be settled in the narrower assemblies, or that pertain to the churches of the broader assembly in common, shall be considered. All such matters shall originate with a consistory and be considered by classis *and the national synod* before being considered by *general* synod. No broader assembly shall have the power to depose an office-bearer or otherwise exercise church discipline, since these powers belong to the consistory.

#### 3. Article ## – National Synods

A national synod, consisting of all the classes within its nation's borders shall convene every year except the year of a general synod unless the convening church, in consultation with its classes' convening consistories, concludes that no matters have been submitted by the classes that would warrant the convening of a national synod. Each consistory shall choose two of its members to be delegated to its national synod. Cancellation of a national synod shall not be permitted to occur twice in succession. If it appears necessary to convene a national synod before the appointed time, the convening consistory shall determine the time and place with the advice of its classes' convening consistories. It shall also determine the time and place for the next national synod, and designate a convening consistory.

#### 4. Article 28 – General Synod

The churches shall meet as a *general* synod at least once every three years. Each classis shall delegate six of its ministers and six of its elders to this meeting the general synod at least eight weeks prior to the start of the general synod. Each general synod shall determine a time and place for the subsequent synod and shall authorize a consistory to convene that synod. If a majority of the classes deem it necessary that a general synod meet earlier than the regular time determined, the consistory charged with convening the meeting shall determine when and where the meeting is to occur.

- 5. Make editorial changes to CO Articles 29, 32, 36, and 66 to change "synod" to "general synod" or "the general synod" and "by synodical decision" to "by a decision of the general synod, and "synodically-approved Consistories" to "the consistories approved by the general synod."
- 6. Make similar editorial changes to Appendix 7 (re. appeals) and Appendix 8 (re. membership).

- 7. Much of the *Regulations for Synodical procedure* can remain the same and function for both the national and general synods. However, the following amendments are here proposed:
  - 1.3 Each consistory shall delegate two of its members to a national synod. Each classis shall delegate six of its ministers and six of its elders to a general synod at least eight weeks prior to the start of the general synod. Consistories and classes which cannot send two the requisite number of delegates shall be required to submit an explanation to synod.
  - 1.4 "<del>synod</del>" to "general synod"

#### Grounds

- 1. This will reduce the size and cost of general synods and promote the deliberative aspect of both the general and national synods. Deeper levels of fellowship will also be enhanced with fewer people in attendance.
- 2. If we learn to meet in general synod once every three years, and in national synod once in two years (assuming it will generally not be necessary to meet in national synod two years in a row, it will help promote the principle of subsidiarity the principle that the best decisions for dealing with an issue are those taken at the lowest (or narrowest) possible level or closest to where they will have their effect. We should not think that we need a general synod every year or every other year to do the work of the church. Bigger isn't always better. Local solutions are usually more informed and effective.
- 3. Dealing with overtures and appeals at a national synod before proceeding to a general synod will help reduce the work of dealing with them at the general synod.
- 4. Reducing the number of ministers and elders at the general synod level will make it easier to obtain delegates given the international travel restrictions presently imposed and which show no sign of being lifted or reversed anytime soon.

#### OVERTURE FROM CORNERSTONE URC SANBORN, IA

#### BACKGROUND

Synod Wyoming (2016) approved the adoption of *Pastoral Advice Regarding Membership Departures* and placed this advice in a new appendix of the Church Order (Appendix 8). Synod Wheaton (2018) decided, with the required 2/3 majority decision for Church Order changes, to codify the advice given in Appendix 8 into Article 64 of the Church Order. The synodical decision was subsequently ratified by the required 2/3 majority of URCNA Consistories.

In making use of the wisdom and provisions of the Church Order and Appendix 8, we have noticed a discrepancy in the language, particularly as it pertains to the matter of erasure. According to Appendix 8.4, the *Pastoral Advice* states that Consistories seeking to erase the membership of one of its members must seek the advice of Classis before proceeding. According to the present reading of Church Order Article 64, however, the Consistories must seek the "concurring advice" of Classis. This is a more rigorous expectation, such that if Consistories fail to receive concurring advice, they may not proceed with the erasure of the membership.

It is our opinion that the present inconsistency is confusing and unhelpful for the churches and that the language of Church Order Article 64 and Appendix 8.4 should be brought in line with each other and harmonized. Furthermore, since we trust the Consistories of our Federation when it comes to the task of the shepherding and discipline of their respective congregations, we believe that it is the language of "advice" which ought to be used in both instances.

#### **OVERTURE**

The Consistory of Cornerstone United Reformed Church (Sanborn, IA) overtures Classis Central US to overture Synod Redeemer (2022) to remove the word "concurring" from Church Order Article 64, in order to make it consistent with the language adopted in Appendix 8.4 of the Church Order.

#### THE PRESENT READING OF CHURCH ORDER APPENDIX 8.4 is as follows:

Consistories may erase the membership of those with whom they have had no contact for at least two years, thus rendering consistories unable to assess that member's doctrine or life. Lack of contact must not be for lack of effort on the part of the consistory, but may be because the consistory cannot locate the member, or because the member is too distant to visit and will not respond to communication attempts. The *consistory should seek the advice of classis* before acting to erase a membership, demonstrating due diligence in its efforts to contact and give pastoral care to the member. The consistory should inform the congregation of this action and the reasons for it. (emphasis added)

<u>THE PRESENT READING OF CHURCH ORDER ARTICLE 64</u> (as amended by Synod Wheaton [2018], Article 89.5, with the required 2/3 majority for Church Order changes) is as follows:

Those who seek the transfer of their membership to another congregation within the federation or one in ecclesiastical fellowship shall request in writing that their current Consistory send to the receiving Consistory an official letter including pertinent membership information and testimony concerning doctrine and life, requesting the receiving Consistory to accept them under its spiritual care. The Consistory may release members in order to affiliate with congregations not in ecclesiastical fellowship when the Consistory

judges that doing so may aid the spiritual growth of the members. *The Consistory may, with concurring advice from classis*, erase the membership of those with whom they have not been able to communicate for at least two years. (See Appendix 8.) (emphasis added)

#### PROPOSED CHANGE TO CHURCH ORDER ARTICLE 64 would be as follows:

Those who seek the transfer of their membership to another congregation within the federation or one in ecclesiastical fellowship shall request in writing that their current Consistory send to the receiving Consistory an official letter including pertinent membership information and testimony concerning doctrine and life, requesting the receiving Consistory to accept them under its spiritual care. The Consistory may release members in order to affiliate with congregations not in ecclesiastical fellowship when the Consistory judges that doing so may aid the spiritual growth of the members. *The Consistory must seek the advice of classis prior to the erasure of* the membership of those with whom they have not been able to communicate for at least two years. (See Appendix 8.) (emphasis added)

#### <u>GROUNDS</u>

1) Consistency between the language of Church Order Appendix 8.4 and the language of Church Order Article 64 is important to prevent confusion and potential disagreement among the churches.

2) Knowing that the Consistories of our Federation humbly strive to do a Christ-honoring job in the exercise of the duties of their office, we believe that this overture helps them toward that end, as the reading of the relevant Church Order Article (64) and Appendix (8.4) will be harmonized.

3) This change would also be in keeping with Church Order Article 55, which only requires Consistories to seek the advice of Classis in matters pertaining to formal, official church discipline.

Please accept this request as in keeping with Article VIII.C of our Rules of Classical Procedure. 1<sup>st</sup> Oak Lawn URC humbly requests up to \$20,000.00 of assistance from the Classis Church Assistance Fund to help us purchase and replace the current a wheelchair lift system in our church building. Over the last 10 years, our church has invested over \$60,000 in the installation and maintenance of the lift. Unfortunately, all maintenance efforts have failed, and the lift is inoperable.

Because our current system is irreparably broken, we are in danger of being noncompliant with ADA regulations. We currently have a two-year window to rectify the situation, or we have been threatened with closure. The need for this wheelchair lift system is also significant as some of our members cannot enter the church sanctuary and other parts of the church building since our facility includes four levels for various activities. The total cost of our lift needs is about \$55,000.00. We have begun fund raising within our congregation to achieve the balance of the funds needed for this project.

We are attaching the letter we earlier sent separately to the churches of Classis. We are early in the process and several churches have agreed to schedule offerings. At the classis meeting we will give an update on donations received by that time.

It would be a great encouragement to our congregation to receive some help from the classical fund as a means of reducing the amount of money we need to spend to meet this need. We are thankful to the Lord for your kind consideration.

### VIII. CLASSIS CHURCH ASSISTANCE FUND

- A. The Classis Treasurer shall separately account for funds designated for the "Classis Church Assistance Fund" (CCAF) and shall distribute such amounts as approved at a meeting of classis.
- B. Each church should decide the level and frequency of contribution to the CCAF, based on the needs that are presented at classis meetings. Such contributions are not part of the Classis "askings" for the ongoing expenses of classis functionaries or standing committee(s).
- C. Churches needing assistance shall present their request in writing, describing the circumstances and nature of the need, the amount of assistance requested, and the expected duration of the need.
- D. Requests for assistance shall be presented to the Clerk of Classis by the deadline for inclusion on the classis Agenda.
- E. Requests for assistance shall be placed on the Agenda and distributed to the churches of classis but shall not be published publicly.
- F. The delegates at classis shall vote on whether to approve all or any portion of the requested assistance.
