TOWN OF OCONOMOWOC BOARD OF SUPERVISORS REGULAR BOARD MEETING MINUTES

March 18th, 2024

Chairman Robert C. Hultquist called the meeting to order at 6:30 p.m. Supervisor's present included John Koepke, John Roelandts, Erik Mullett, and V.J. Scully. Those present stood to recite The Pledge of Allegiance.

<u>Approve Minutes from Regular meeting on March 4, 2024</u>. – Supervisor Koepke made the motion to approve the March 4th meeting minutes as presented. Supervisor Roelandts seconded the motion. Motion carried by unanimous voice vote.

Tim Kay, Municipal Court Judge gave an overview of Lake Country Municipal Court and spoke briefly about the City of Delafield.

Sandra Larsen, E. Lindy Lane, stated the road was moved four feet towards her property and does not want the road wider and does not want any of the trees cut down.

Heidi Leibundgut, 275 N Jaeckes Drive, stated she is against the sewer and has a holding tank.

 LLC on Breezy Point Road. The Board agreed to have Administrator/Planner Herrmann talk with the Town Attorney, Tracy Murn, and review all the options the Town has.

Consider and Act on the rezoning request (RZ139) of Cypress Tree, LLC, c/o Terry Bartowitz, to amend the District Zoning Map of the Waukesha County Shoreland Protection Ordinance to rezone portions of the property from FLP Farmland preservation District to the R-1 Residential District to allow for the creation of two (2) approximately 2 acre residential parcels in accordance with the density standards of the Farmland Preservation District. The subject property is described as part of the NE ¼, SW ¼, and SE ¼ of Section 14 and part of the NE ¼ of

Section 23, T8N, R17E, Town of Oconomowoc. (Tax Key No. OCOT 0488.994.003 and 0488.994.005) – Supervisor Roelandts made the motion to approve the rezoning request (RZ139) of Cypress Tree, LLC, c/o Terry Bartowitz to amend the District Zoning Map of the Waukesha County Shoreland Protection Ordinance to rezone portions of the property from FLP Farmland preservation District to the R-1 Residential District to allow for the creation of two (2) approximately 2 acre residential parcels per the recommendation of the Town Plan Commission. Supervisor Koepke seconded the motion. Motion carried by unanimous voice vote.
