Kristine Smith, N53W34400 Road Q, questioned the amount that was being approved to Wolf Paving and if it was to pay for the work done on Road Q and would hope that there are plans to still fix the Road that was never fixed properly to begin with.

Administrator/Planner Herrmann gave all the Board members the qualified coverages in Waukesha County; he also stated that the state has chosen Dean, which is the lower plan, however the state says of all the qualified plans in Waukesha County the Town can pay the maximum average of all of the plans combined to come to a total of \$1863.42 if the Town picks Dean, you can still contribute \$1863.42 towards other plans for the employees; Supervisor Husak stated that the town currently has WEA Trust and the new amount for next year is \$65 a month more than what they are currently paying and she also stated that she does not like the fact the Dean care does not cover Children's Hospital, which most of the employees have children and the fact the Town's Clerk would not be covered because Dean care does not cover Washington County. Supervisor Koepke made the motion to go with WEA Trust East for 2015 with the 87 percent of the premium being covered by the Town. Supervisor Largent seconded the motion. Motion carried by unanimous voice vote.
- 3. Consider and Act on Housing Status for N57 W34577 Road G. Administrator/Planner Herrmann stated that Commissioner Largent received a weed complaint. He took the time with Commissioner Largent to visit the property. He also stated that the property is not in good shape and was asking the Board how he should proceed with this situation Supervisor Koepke made the motion to write a letter to the property owner regarding the property. Supervisor Largent seconded the motion. Motion carried by unanimous voice vote.
