- 1. Approve Minutes for June 4, 2012 Town Plan Commission Meeting: Commissioner Navin made a motion to approve the minutes as presented. Commissioner Peregrine seconded the motion. Motion carried by unanimous voice vote.

- 3. Consider and Act on Conditions of Approval for the Conditional Use Permit for George & Doralise Kaun, N87 W34757 Mapleton Road, Oconomowoc, to allow outdoor and indoor commercial storage of vehicles, boats, recreational vehicles, etc. on property located in the NW ¼ of Section 12, in the Town of Oconomowoc: There was discussion as to item numbers 2, 5, 8 & 9 in the Planner's report. It was determined to remove item #2 as it is required by the County. Item #5 be removed, item #9 should be listed as 200 boats, trailers, and recreational vehicles maximum dependent upon the new building being built, and item #8 stays as written. Commissioner Peregrine made a motion to recommend approval of the conditional use permit with the changes to the Planner's report as indicated. Commissioner Largent seconded the motion. Motion carried by unanimous voice vote.
- 4. Consider and Act on Site Plan/Plan of Operation for Premold Corp., W395 N5657 Frontier Road, Oconomowoc, Wisconsin to allow a total expansion of 38,000 square feet to the current building on property described as Lot 2 Certified Survey Map No. 8786, being a part of the SW ¼ of Section 30, in the Town of Oconomowoc: Bob Buchta was present to explain the plans for remodeling by Premold Corporation. Commissioner Peregrine made a motion to recommend approval to Waukesha County subject to the Planner's report. Commissioner Navin seconded the motion. Motion carried by unanimous voice vote.
- 5. Consider and Act on the July 2<sup>nd</sup>, 2012 Plan Commission meeting: Commissioner Navin made a motion to cancel the July 2<sup>nd</sup> meeting. Commissioner Husak seconded the motion. Motion carried by unanimous voice vote.
