December 2, 2013

- Approve Minutes for November 4, 2013, Town Plan Commission Meeting: Commissioner Navin made a motion to approve the minutes as presented. Commissioner Husak seconded the motion. Motion carried by unanimous voice vote.

- 3. Consider and Act on Certified Survey Map for James Priest, N51 W35378 River Road, Oconomowoc, Wisconsin: Administrator/Planner Herrmann stated that the Priest's are changing the common lot line, the property line of lot #2 on the northwest side will be moving which will increase the lot size and lot #1 will become smaller. It was noted that on the survey the lake is incorrectly named, it should be Okauchee Lake. Commissioner Peregrine made a motion to recommend to the Town Board approval of the CSM with the name of the lake corrected as well as #2 of the planner's report. Commissioner Garvey seconded the motion. Motion was carried by unanimous voice vote.
- 4. Consider and Act on Site Plan/Plan of Operation for Ami Shockley to operate a Tavern with Living Quarters to be known as "Whiskey Waters" at N50 W35124 Wisconsin Avenue, Oconomowoc, Wisconsin: Ms. Shockley stated that the plan of operation will remain the same as what was Lou-eze's Pier 53 with the exception that she is requesting to be open seven (7) days a week. Commissioner Peregrine asked Ms. Shockley if she read the planner's report and if she had any questions. Ms. Shockley responded that she did and she had none. Commissioner Peregrine made a motion to recommend to Waukesha County approval of the site plan/plan of operation subject to the planner's report dated November 26, 2013.
