Public Hearing to consider the request of Kelly Conley, N52W37049 Washington Street, Oconomowoc, Wisconsin 53066, for the construction of a 6' fence. The fence is to be located along the east end of the house. The proposed construction does not meet the Town of Oconomowoc Code of Ordinance Section 144-5. The property is described as LOT 6, 7,8 Block 15O Oconomowoc Heights Section A, Corrected Plat, being a part of the NE ¼ of Section 33, T8N, R17E, Town of Oconomowoc, Waukesha County, Wisconsin.

Kelly Conley, N52W37049 Washington Street, spoke on the need for the fence for her active dog. Pictures of her house were shown. She is opposed to an underground fence due to the possible dangers involved. James and Judith Kaestner, N52W37111 Washington St., spoke in favor of the fence. Kathy Shores, 813 Washington St., spoke in favor of her neighbor's fence.
