- 1. Approve Minutes for December 15, 2014 Town Plan Commission Meeting. Corrections were made to the minutes as to who opened and closed the Joint Public Hearing change to Town Chairman Hultquist. Commissioner Navin made the motion to approve the minutes as corrected. Commissioner Garvey seconded the motion. Motion carried by unanimous voice vote.

- 3. Consider and act on Site Plan/Plan of Operation for Freedom Arms Unlimited, LLC to operate a retail firearms store at W359N5828 Brown Street in the Town of Oconomowoc. Petitioner, Craig Lentz, presented his intentions for his business.
