WCCA Meeting Minutes **September 17, 2025**

Luling, Vice-President called the meeting to order at 730 pm. The meeting was sponsored by Daniel Boone Conservation League at Daniel Boone Conservation League.

The meeting was attended by 11 individuals, comprised of Club Delegates and Wisconsin Conservation Congress Delegates. Quorum was declared

Secretary's Report

Membership was asked if there were any corrections or additions to the August 20, 2025 General Meeting Minutes. Motion by Tackes, second by Perock to accept the Minutes as published. Motion carried. Minutes are always posted to the WCCA Website.

Treasurer's Report

- Report presented by Farchmin to Membership in attendance. A motion was made by Lindemann, second by Perock to accept the Treasurer's report, subject to audit. Motion carried.
- Discussion held about the cost of the guns for the banquet. We made money on handguns, but lost money on lost money on rifles and shotguns. Net loss about \$451. Membership wanted less guns but higher value on those we do purchase. Put some of the better guns on the flyer.
- Report from Shook about Vendor used from last year. Shook met with them once giving them the list of guns we were looking at. He was told they would call back with the price list in time for the September meeting. Shook called them a week later and they had the list next to their phone, but didn't have prices yet. Shook then called on Sept. 16th, manager left for the day. Shook called again today, the 17th and was told the manager wasn't in. Shook is concerned that we may not get a good price on the guns, but also, we may not even get the guns in time for the banquet. Shook is now checking with other Vendors and hopes to have a report by October meeting.
- Membership is also concerned for the lack of cooperation from the past Vendor. It is strongly suggested we find another Vendor. Midwest Firearms, Fleet Farm and Wisconsin Firearms & Training were suggested.
